### 3. 2020 Onion Season Review - Bruce Klamer

The group of appointed board members took turns giving updates on season. Bruce Klamer said the season was average to above average. There are almost no onions left in Michigan as they have sold and many due to the federal food boxes. The stored onions will be gone during January most likely. Mike Bosch said the onions on muck were good but the onions on mineral soil were poor due to small size. Kristin Oomen said it was above average across the board with pretty much the same in Wisconsin.
