3. 2023 Onion Season Review - Mark Nail

Bruce is working with NOA to come up with NOA Storage Report by 12/1. Stock on hand is needed. We have a good handle on acreage, just took off 200 for 2023 from 2022. Most onion central to west were average. Central mid had  $\frac{2}{3}$  yield. 800 bags per acre of 100 weight bags. Prepack prices were good. Prices good early of \$.30 per lb and now bad of \$.20 per lb.

#### 5. MDARD Report – Heather Throne

Heather reviewed current happenings at MDARD. MDARd will begin processing payments for SCBG on Monday. If a new Farm Bill is not voted on then contingent language will be written for the next round of SCBG. MDARD will be using a new grant system for the next round of SCBG. This new system will be announced in December. Rural Dev Grants of \$100K with 30% match (by county, housing projects etc) until 1/9/2024. There is \$30 million for wastewater grants. USDA also has given MDARD \$10 million for resilient food systems for infrastructure and equipment. Either the wastewater or resilient grants will be between \$225K and \$2 million.

Bruce will get Saltanat to Keilen and Valley Farms. DanBrainard will be working some on white campion. Growers are still a bit unsure when to kill white campion which is well established.
