The board said outstanding 2024 onion assessments need to be collected with a text notification no later than 6/15/2025, a letter no later than 07/01/2025, a certified letter no later than 08/01/2025, and then turned over to MDARD no later than 09/01/2025.

5. 2024 Onion Season Review - Mark Nail

Mark Nail said he has average year with slight above average, with average quality. East side used an internal sorter. Eding qualities are good and yields are up in 2024. NY and WI are the same. About 60% of 2024 crop in MI remains to be shipped. Right now\$13\50lbs red, \$10\50lbs yellow, \$7\50lbs pre-pack.

6. MDARD Report – Jeff Haarer

MDARD had 100 apps for underserved grants, which is closed. SCBG RFP going out 12/10. MI had 30 dairy with HPAI. Poultry restrictions are lifted. Rural Dev Grants on 12/5 and resilient food systems grants are going out.

7. MSU Extension Report – Ben Werling

GREEEN by Jan 1. Lorsban is complicated and should be considered no usage for onions. ESA is holding up release of new Syngenta product. MSU will have a new weed scientist by Aug 1. MSU is working on Bulletins Live 2 for ESA hitlist.

8. Onion Seed Variety Trials 2024 – James Young

Just like 2023, James has the list of the onions in the 2024 trials. James will take onions to Expo. James will prepare the one page spreadsheet on the trials.
